



Sanction Guidelines & Form

Fiscal Year is November 1st thru October 31st

Sanctioned events will be listed on the United Clogging Association website. [Click here for Calendar](#)

Sanctioned Competitions on consecutive weekends must be at least 200 miles apart.

Sanctioned Competitions on the same weekend must be at least 400 miles apart.

Directors of Competitions are not allowed to override the United Clogging Association rules.

The United Clogging Association Score Sheets must be used with NO changes.

Sanctioning fee is \$100.00. Sanctioning fee & form MUST be RECEIVED 2 weeks prior to your competition date. Failure to meet deadline will result in sanctioning being cancelled.

Every competition must be fully staffed ([Click here for the United Clogging Association Staff](#)):

- 5 Certified Judges
- 1 Certified Rep (May be one of the judges who is a certified rep)
- 1 Certified Scorekeeper
- 1 Timekeeper (Rep appoints a judge or agrees to a volunteer)
- 1 Runner for Score Sheets

Fees and hotel accommodations should be agreed upon prior to Competition for all Staff.

The following fees are **required minimum** fees for ALL Sanctioned Competitions:

- Judges' fee is at least \$225.00 per day for each judge for an average size competition.
- Scorekeeper fee is at least \$300.00 per day for an average size competition.
- If the Rep is also a Judge, this person will be paid \$50.00 more than the Judge fee.
- If a Judge is the Timekeeper, this person will be paid \$25.00 more than the Judge fee.
- These fees should increase if the competition lasts more than 12 hours.
- These fees should increase if the paid staff drives more than 3 to 4 hours to attend.

Sanctioned Competition Directors may:

- Set their own entry fees.
- Change age divisions for Solos. (Traditional, Contemporary, Acapella, Flatfoot, and Novice).
- Give awards at their own discretion.

Sanctioned Competition Directors must:

- ❖ Follow the United Clogging Association Rules
- ❖ Use the United Clogging Association official Score Sheets, with NO changes
- ❖ Ensure ALL Directors & Dancers, at Sanctioned Competitions, cannot be staff members in any capacity.
- ❖ Ensure all Staff Members have your contact information for emergencies.
- ❖ Supply the Time Keeper with a copy of the time requirements (max & min), located on the first page of the rules.
- ❖ Supply Judges, Scorekeeper, Runner, and other staff as needed a copy of the program.
- ❖ Notify all Judges if a Dance off is skipped for Grand Champion solos before scoring the category.
- ❖ A Competition Director MAY NOT ALLOW their own team to compete at their own COMPETITION. (No Exceptions).

The Rep may call the Team Directors to the table for any deductions given.

Timekeepers will notify the Rep immediately of all time deductions.

The Score Sheet Runner should meet with the Scorekeeper (prior to competition beginning), for instructions regarding expectations.

- ❖ The Runner is expected to scan each Judge's scoresheet for unmarked areas, correct category, correct age division, both decimal points marked, correct page order, and for the Judge's signature. They should make sure they have a Rep sheet and Timekeeper sheet when necessary, and a total of 5 score sheets. All needed changes should be made before the Runner gives score sheets to Scorekeeper.

The Scorekeeper should send all team results to the United Clogging Association Registration Chairperson, the United Clogging Association Secretary, and the Competition Director, within 3 days of the end of the competition. This also includes the Grand Champion male and female winners in Solos (Traditional, Contemporary, Novice, Flatfoot & Acapella) and the Grand Champion Duo/Duets. This information should include the director's name, address, phone number, and email.
